#### **Boom In Indian Ceramics Industry**

Construction, infrastructure development and utilization of building materials are on the rise in the country where Ceramics plays a vital role, particularly the vitrified and the porcelain tiles for the walls & the floors. The Ceramic industry in India generates a revenue of Rs. 25000 Cr. exporting to various destinations including Middle East & Europe markets and is on the verge of doubling it to Rs. 50000 Cr. by 2020 and thus aims to become the global leader in next 6 years. The industry is driven by both domestic and EXIM markets.

During a road show to promote "Vibrant Ceramics Expo & Summit 2017" at Visakhapatnam recently it was envisaged that India would emerge as the largest producer of ceramic goods with the availability of superior quality mineral wherein Andhra Pradesh is expected to play a pivotal role.



The Sunrise State - Andhra Pradesh (AP) & Telangana state together

contribute Rs. 1,000 Cr. to this segment currently. A Ceramic Industrial Township is being established in Andhra Pradesh, thanks to its abundant resources in terms of Electricity, Gas, Water, Land and Minerals. As clay is available in plenty at West Godavari district, it's where the township is planned to be set up in 3000 acres.

Considering the advantages in AP, its scope to establish and contribute in ceramic industry is high not only due to the availability of resources but also for its logistics connectivity. The West Godavari region, which is being chosen for the township is well connected through the national highway (NH 16) to the Port City. Visakha Container Terminal has already been playing a key role in handling the ceramic shipments from & to international markets. Morbi trade in Gujarat has been regularly shipping ceramic products from Mundra port to Visakhapatnam from where it gets distributed to the entire southern region.

The existing ceramic industries in and around A.P are going in for expansion as they find huge markets in South and North India. With better quality products being produced in India itself, the imports from China especially would become a thing of the past and the domestic markets have opened up new avenues for ceramic industry where Visakhapatnam port through the sagarmala project has become the preferred gateway. Blessed with a vast hinterland covering 8 states through well connected rail & road network, the only established container terminal in the state has been significantly contributing to the faster transportation of these products.

#### Snooker Tournament @ Port City

For the first time in the history of Visakhapatnam, "The 2017 Indian Open World Snooker Ranking Tournament" was held as part of the global vision to showcase the game. This enviable product is now attracting more carriers to venture in to the fray by offering direct service to the Himalayan Nation's ICD Birgunj.


## VCT-CFS : Expertise In Handling Ores (containers)

circular released by The Central Board of Excise & Customs recently states that the ICDs/Container Terminals are required to be equipped with RFID readers to handle the factory stuffed containers. Visakha Container Terminal as always has been proactive in procuring these RFID readers that comply with the standards prescribed by CBEC and also has gone a step further in identifying the vendors who would provide the seals on a large scale as per the requirement of Customs thus making the lives easier for the exporters.

It's a known fact that the marine products exports through the port city has increased by 32% in FY 17 and currently growing at the rate of 34% where the contribution from Bhimavaram region alone is significant. In order to cater to this burgeoning traffic, VCT has already increased the reefer plug-points to 366 and the RFID initiative only shows how the terminal has been advancing as a modern gateway on the east coast of India. With more new services soon adding to its basket make the portfolio of the terminal complete in all respects and thus justifies why the sea food exports are in safe hands.
